csv-Export: Partnerships list

To export all an account's partnerships including the details in the Yieldlab UI go to Partnerships > Partnerships List and select Download Partnerships List.

All the account's partnerships will be exported in csv format and the information below will be provided.

csv-Import: Partnerships list

Importing the partnerships csv list allows you to create multiple new partnerships or modify existing partnerships. In the Yieldlab UI you can upload your partnerships csv list under Partnerships > Partnerships List > Upload Partnerships.

Whether you are creating new partnerships or modifying existing ones, the following rules apply for the import:

- The uploaded file must be a semicolon-separated csv file.
- It must include the title line with the exact column names.

If you wish to enter several values for a parameter, these must be separated with a vertical bar | . (Please note: Do not use spaces after the bar).

Do not enter any partnership IDs when creating new partnerships via csv import.

When changing existing partnerships via csv import, the existing IDs of the partnerships to be changed must be specified.

Partnership IDs must not appear more than once within the csv file.
